Explanation of Responses:

1. 18,513,482 of the total reported securities are owned by the following subsidiaries of Berkshire Hathaway Inc. ("Berkshire"): Government Employees Insurance Company (11,208,904), GEICO Indemnity Company (6,795,084), GEICO Advantage Insurance Company (223,398), GEICO Choice Insurance Company (222,842), and GEICO Secure Insurance Company (63,254). As Berkshire is in the chain of ownership of these subsidiaries, it may be deemed presently to both beneficially own and have a pecuniary interest in all shares of Common Stock presently owned by each subsidiary. Warren E. Buffett, as the controlling stockholder of Berkshire, may be deemed presently to beneficially own, but only to the extent he has a pecuniary interest in, the shares of Common Stock presently owned by each such subsidiary. Mr. Buffett disclaims beneficial ownership of the reported securities except to the extent of his pecuniary interest therein.

2. 17,582,088 of the total reported securities are owned by the following pension plans of Berkshire's subsidiaries: ACME Brick Company Pension Trust (350,000), Scott Fetzer Company Collective Investment Trust (200,000), BNSF Master Retirement Trust (6,850,000) and Berkshire Hathaway Inc. Consolidated Pension Plan (10,182,088); each of Berkshire, Mr. Buffett and these pension plans disclaim beneficial ownership in such shares.
